In support of Work Experience Certificate, candidates are advised to carry copy of Bank Statement / Salary Credit statement of the experience claimed period reflecting the credit of Salary by the past/present employer.
- ii) Mere short-listing for the 2<sup>nd</sup> Phase of selection process shall not automatically make an applicant eligible for recruitment.
