The requirement to register with the e- procurement portal is mentioned in the above-mentioned website. For submission of Financial bid, bidders are advised to go through the "Instruction to Bidder for submission of Financial Bid" annexed with the Appendix-IB (Letter comprising the Financial Bid).

Date & Time for opening of Tender: The Technical Bids will be opened at 11.00 hours on 13-02-2024. The Financial Bid shall be opened on the date to be intimated separately to the successful bidders who satisfy conditions of Technical Bid.

Eligibility criteria (minimum): The contractor should have the experience of successful execution of similar works for any Govt. agency during the last 7 years ending 31st March, 2023 meeting any of the following three conditions:

- a) Three similar completed works costing not less than the amount equal to 40% of the estimated cost,
- b) Two similar completed works costing not less than the amount equal to 50% of the estimated cost,
- c) One similar completed works costing not less than the amount equal to 80% of the estimated cost.

Similar works would mean civil works involved in the construction of Building structure.

The online tender processing fees and the Earnest Money Deposit (EMD) to be deposited online in the e-procurement portal of Govt. of Assam i.e., <u>www.assamtenders.gov.in</u>.
